Editorial 2016

Stephen P. Jenkins¹

This editorial is the second of my annual reports to our authors, readers, and referees, aiming to provide an easily accessible source of information about acceptance rates and manuscript processing times, editorial policy, nor public acknowledgement of the individuals who help make this journal what it is. Please see Jenkins (2015) for further discussion of editorial practice, Special Issues and Forums, Rediscovered Classics, replication policy for empirical papers, and advice for authors submitting original research articles.

Publication statistics

Publication statistics are derived from Springer's Editorial Manager software, and reflect the situation in mid-2016.

The *number of submissions* continues to rise: see Table 1. There were 240 Original Research Article submissions in 2015, compared with 198 in 2014, representing an increase of 24%. We expect around 270 submissions for calendar year 2016, having already received 185 new submissions between 1 January and 31 August.

The *rejection rate* has been increasing slowly over the last five years, but has now levelled off. It was 91% in 2015 compared with 90% for 2014. See Table 2.

Manuscript processing times have continued to decline: see Table 2. The mean number of days from submission to first decision was 88 in 2013 and 53 in 2014 but only 29 days in 2015. The mean number of days to final deposition Accept fell from 407 in 2014 to 279 in 2015, and to final deposition Reject from 60 in 2014 to 46 in 2015.

The *number of submissions that is desk-rejected* has continued to rise: see Table 3. The desk-rejection rate of original research articles may be calculated as a fraction of submissions, or of articles decisioned. Using the first measure, the rate was 49% in 2013, 57% in 2014, and 69% in 2015. Using the second measure, the rate was 50% in 2013, 61% in 2014, and 75% in 2015. We continue to aim to make desk-rejections within seven days of receipt of the submission and also to provide some comments to authors. Our desk-rejection policy is discussed in more detail by Jenkins (2015).

The *total number of articles published* in 2015 was 39 including 11 in a special issue on Appraising Cross-National Income Inequality Databases. Submissions in 2015 came from 31 countries, including 50 from the USA, 16 from Italy, 14 each from Germany and the UK, and 10 from France.

The journal's *Impact Factor* which had been increasing year on year since 2010 fell between 2014 (1.362) and 2015 (1.041). The 2015 5-year Impact Factor is 1.837.

The 10 *most downloaded papers* from the Springer website in 2015 are shown in Table 2. As for 2014, the majority of the papers appeared either in a themed Special Issue, or in the Rediscovered Classics section. The 15 *most cited papers* (according to Google Scholar, as at August 2016) are shown in Table 2, with papers ranked by number of citations per year. Original Article submissions feature more prominently in this table than Table 1 but, nonetheless, a notable fraction appeared either in a themed Special Issue or in the Rediscovered Classics section
